1. All booth participants must pay a fee of \$35.00 per vendor space (fits a 10X10 canopy). Fee must accompany this Contract to secure the item(s) sold.
2. Booth locations will be assigned –Set up begins at 10:00AM
3. You will be allowed to park within the grounds to set up your area. However, vehicles must be moved by 12:00 Noon.
4. Vendors will be responsible for cleaning their areas after the festival. **Dumpsters will be available for all garbage disposal.**
5. Electricity will be provided for additional charge of \$10.00 (*We ask that you limit your power requirements to 20 – 30 amp service*). Provide your own cords.
6. Vendors are responsible for providing their own tables, chairs, tarps, garbage bags, and booth set up. Used Cooking oil must be disposed in closed containers.
7. Vendors must only sell the items listed on this agreement.
8. All vendors and their personnel will be given two Vendor Wristbands for identification to get admission to the grounds. Wristbands will be checked.
9. **The Chamber of Commerce will be solely in charge of selling all Beverages –including but not limited to: Water and Soda Pop beverages, and Beer/Wine sales. No Exceptions**
10. Food vendors must have Food Handlers Permit and Temporary Vender Permit.

By signing this agreement, individuals, groups, clubs, organizations, families, or booth vendors will not hold the Chamber of Commerce liable for accidents, incidents, or wrong doings concerning the Bullnanza Event. Booth vendors will not hold the Chamber of Commerce responsible for any lost, damaged, or stolen items.
